**\* Important Note:** Airline Charges are based on per kg of Chargeable weight. Chargeable weight is higher of the Actual vs Volumetric Weight of the Box. Eg. If your box is 5kg and size 30x40x40cm.

Actual Weight = 5kg and Volumetric weight =  $(30 \times 40 \times 40 / 6000) = 8\text{kg}$

Airline will charge based on the higher one which is 8kg Chargeable weight.
